DRAUGHT BEER DUTY

We recognise that this Government has done a huge amount to support the hospitality industry throughout the covid pandemic, and we are grateful for that support. However, despite this help, in our constituencies, we are seeing many pubs and clubs struggling to survive. Some will simply not reopen. We are particularly concerned about 'wet led pubs' who have not benefited from the cuts in VAT but do have all the additional costs of covid.

Given the important social as well as economic contribution pubs make to the communities we represent, we think it is vital we do more to help them not just survive but thrive in the long term. Pubs employ a higher rate of staff than supermarket outlets, are best placed to provide supervised and safe drinking, and through things like sports teams and community activities, make a massive difference.

In short, if we didn't have the pub, we would want to invent it.

For that reason, we would ask you to consider introducing a specific Draught Beer Duty. A cut in duty for draught beer would allow us to target support to those pubs and clubs in a way nothing else could. A lower beer duty on draught sales in pubs, clubs and bars, compared to off sales in supermarkets, would be a huge boost to their ability to prosper and rebuild from Covid-19. Moreover, it would be easy to understand, simple to administer, and importantly, demonstrate this Government's clear commitment to Britain's pubs.

Leaving the European Union provides us with a unique opportunity to offer this support. We believe it would work because:

- Beer accounts for almost half of all drinks sold in the 'on' trade
- 98% of all the draught beer drunk in this country is brewed here. It is a uniquely British product and the knock-on benefit would therefore be kept in the UK and not exported
- It would especially help 'wet led' pubs and clubs, so is targeted

We understand that Treasury are currently considering their response to the Alcohol Duty Review. On behalf of pubs, clubs, and brewers in our constituencies, we would ask that you consider Draught Beer Duty as the way to help them thrive and survive as we recover from the covid pandemic.
